CONSTITUTION.

ADOPTED IN 1894.

- ARTICLE 1. This Association shall be known as the Shiawassee Baptist Association, and shall be composed of Baptist Churches and each Church shall be entitled to three delegates, and an additional delegate for every fifty members.
- ART. 2. This Association has no power as a LEGISLATIVE body, but as an INDEPENDENT body has power to govern itself, and disclaims all interference with the particular discipline of individual Churches. Yet we deem it our privilege to judge for ourselves of the propriety of continuing any Church in our connection.
- ART. 3. The objects of this Association shall be to gather information in regard to the state of Churches, both as respects STATISTICS and BRILIGION, to promote the Christian fellowship, and to sustain the various benevolent objects connected with the promotion of Christ's kingdom.
- ART. 4. This Association shall, by delegation of Churches, meet annually on the first Tuesday, Wednesday and Thursday of June and shall hold such other meetings as the body may direct.
- ART. 5. The officers shall be a Moderator, Clerk, Treasurer, Auditor, President of Pastors' Conference, Associational Superintendent, Associational President B. Y. P. U., Superintendent of Woman's Mission Work and Missionary Committee of Three (to co-operate with the State Board), to be elected annually, by nomination or ballot, to continue in office until others are elected. It shall be the duty of the Associational Superintendents and Presidents to have general oversight of the work in their departments throughout the Association and to develop and encourage the same and to assist the Program Committee in making out the program for the anniversary meeting.
- ART. 6. Each Church shall send with its delegates a letter containing an account of its numerical changes and generally what pertains to its peace and prosperity and money for Minutes. Any Church neglecting to do this for three successive years shall be dropped from the Minutes.
- ART. 7. Churches giving satisfactory evidence of being sound in doctrine and correct in practice may, on application, be admitted into this Association.
- ART. 8. This Constitution may be altered or amended at any annual meeting, provided that notice of the proposed amendment has been given at the previous annual meeting.

STANDING RESOLUTIONS.

RESOLVED, That the Treasurer be instructed to pay over all moneys that are in or may come into his hands to the several agents to whom said money belongs, and take a receipt therefor.

RESOLVED, That any member of this Association whose name is in the Minutes present at the meeting of any Association with which we correspond shall be a delegate to that Body.

RESOLVED, That the Clerk be instructed to forward the Minutes to each Assoation and corresponding Body in the state. Also to the Colgate Library, Hamilton, N. Y, and to the Library of the University of Chicago.

RESOLVED, That Churches requesting admission to this Association be required to show a formal recognition from a council of Baptist Churches convened for such purpose.

VERNON, Mich. June 5, 1894.

Called to order by E. D. Way. Prayer and praise service led by Miss Elva Quick, of Ovid, Appointment of committees by the Chair.

- H. A. Dennis, of Laingsburg, read a paper on the subject "Why I am a Baptist." A well written and well read paper, which was followed by comments by Rev. I. W. Lamb, Rev. - Mrs. J. E. Littell, of St. Johns, presented an instructive paper on "Junior Work." This work has been neglected until recently but covers more than the Sunday School. - 3. Arrangements were made for Workers Conference in connection with the B. Y. P. U. and S. S. Rally held in Lansing, December 7 and 8, 1893.
- 4. Letters with program of Conference and Rally were sent to all the Churches, urging them to send delegates.
- 5. Letters with Collector's Cards for State Mission contributions were sent to each Church asking that this important work should be attended to at the proper time.
 - 6. Advised State Board in regard to aiding Laingsburg and Chesaning.

7. We very much regret that we were not able to do more work during our term of office.

Following the order, Moderator resumed the chair and after singing, Committee on Resolutions reported as follows, which after separate motion each one was respectively adopted:

RESOLUTIONS.

Resolved, That we more heartly support all our Mission Societies established for carrying forward denominational work; each having as the years move on, a dearer place in our hearts on account of the wonderful way in which God through them is lengthening the cords and strengthening the stakes of His habitation in the earth with His people.

Resolved, That we commend the Publication Societies literature, "The Michigan Christian Herald" and "The Baptist Union" in every Home, as an educational incentive in all Christian work.

Resolved, That encouraging reports from 21 of our 22 Churches, giving such unprecedented increase numerically and we trust spiritually, calls loudly upon us for special thanksgiving to God for his merciful blessings; also to covenant by the leading of His Spirit this coming year to put forth greater efforts in His service.

The Unity of the Spirit being the bond of perfectness: hence greater unity means nearer perfection.

Therefore, your Committee would cautiously suggest, that each Church constantly bear in mind that it is the Church, "The body of Christ," which bears all its branches, such as the Sunday School and Young Peoples Societies, in all their work and not these branches standing alone, nor bearing the Body. We further suggest that in our next Associational gathering these subjects be given a place in and not distinct from our proper Associational program.

Resolved, That the present unrest, strikes, lockouts and consequent distress in all our labor circles, such condition being a product of and each outbreak and common weal army march, fostered by the legalized liquor traffic, together with

the unearthing of corruption in high places, is as sure an indication as the sound of going in the tops of the Mulberry trees, that now is an acceptable time for concerted action in an attempt for Constitutional prohibition of the liquor traffic; to this end we urge all pastors to thunder it in unmistaken terms from their pulpits that the people may prepare themselves to act as one man and act now for the protection of the home. We urge all Christian voters to see to it that their candidates be men pledged to that principle. We further urge all to pray, petition and work for the near accomplishment of that much desired end.
