

ORDER OF BUSINESS.

- 1. At every sitting, business shall be opened and closed with devine services by the Moderator, or whomsoever he may appoint.
 - 2. Reading letters from churches and enrollment of messengers.
- 3. Appointment of Committee on Credentials and enrollment of Messengers and Permanent Organization.
 - 4. Reading of the Constitution and Rules of Decorum.
 - 5. Reading letters from new churches and Associations.
- 6. Invitations to Corresponding Messengers and visiting brethern to participate in all the deliberations of the Association, but vote on none.
- 7. Appointing Committees on Devotional Exercises, Business, Correspondence, Finance, Ministerial Destitution, Sunday Schools, Missions, College, Place of next Meeting, Annual Sermon, Writer of Circular Letter, Printing and Distributing Minutes, and on Obituaries.
 - 8. New Business.
 - 9. Reports of Committees.
 - 10. Minutes for amendment or approval.
- 11. Vote of thanks, adjournment, valedictory by the Moderator, and parting hand.

Whereas, Through the living and tender mercies of Almighty God, we are privileged to meet in a District association; and whereas, an opportunity has presented itself to us to devise means for the intellectual, moral, and religious culture of our race; we therefore adopt the following Constitution:

ARTICLE I. This Association shall be known as the Central District Association of Colored Baptists in Kentucky. The object of this Association shall be the promotion of purity, doctrine, and union fellowship, and to advance the cause of our Lord and Saviour Jesus Christ; also the cooperation in the promotion of Sabbath-schools and missionary work throughout the District, by meeting annually for mutual and religious counsel.

ART. II. All regular Baptist Churches in the District shall be entitled to membership in the Association. Each church composing the Association shall be represented at each annual meeting by messengers and letters, setting forth the spiritual condition of the church, and the extent of their benevolent and missionary operations.

ART. III. Each messenger shall, before taking his seat in the Association, give satisfactory evidence to the Association of his appointment by the church he represents.

ART. IV The officers of this Association shall be a Moderator, an Assistant Moderator, a Recording Secretary, a Corresponding Secretary, and a Treasurer, to be elected annually, by ballot or otherwise, their duties to be common to their office, as in similar associations, and an Executive Board of seven.

ART. V. The annual meeting shall be held at such time and place as the Association may direct.

ART. VI. The Treasurer shall hold all funds of the Association, and shall pay them out when ordered by the Moderator, and the Moderator's order shall be his voucher; also said Treasurer shall be required to give sufficient bond and security for the safe keeping of all money committed to his care. He shall give a full report of all money received to each annual meeting.

ART. VII. Each church shall be entitled to three messengers, the membership not exceeding 800, and for every 200 over 800 an additional messenger.

ART. VIII. This Constitution may be altered or amended at any annual meeting of the Association by a two-third vote of the members present.

RULES OF DECORUM.

- 1. No brother can speak more than twice on any subject without permission from the Association.
- 2. Every brother must respectfully address the chair standing. He must confine himself to the subject under debate, and avoid personalities.
- 3. Any brother violating any of these rules may be called to order, in which case the Moderator shall immediately decide who is entitled to the floor. There may be an appeal to the Association.
- 4. No motion can be put without a second, and, if required, reduced to writing.
- 5. When two or more brothers rise at once, the Moderator shall decide who is in order.
- 6. Before the question is put on any motion, it shall be distinctly stated by the chair.
- 7. When a subject is under debate, no motion shall be in order but to lay on the table, to postpone, to refer to a committee, to amend, to adjourn.
- 8. A motion to lay on the table, reconsider, and adjourn shall not be debatable.
 - q. No member shall absent himself without permission from the chair.
- 10. If any proposition or motion contains two or more points, it may be divided at the request of any member, and the vote taken separately.
- 11. Any motion may be suspended when deemed necessary, by the concurrence of two-thirds of the members present.
- 12. No motion made and lost shall be recorded, unless so ordered at the time.
- 13. The Minutes may be read leisurely, and corrected, if necessary, before the rising of the Association.
- 14. Any member of the Baptist Church may become an annual member of this Association by paying 50 cents, and a life member by paying \$2.50.
- 15. These rules may be amended or altered by the concurrence of two-thirds of the Association at any annual meeting.

Ministers' and Deacons' Meeting.

FIRST DAY—MORNING SESSION—TUESDAY, July 10th, 1883.

The Ministers and Deacons assembled in the Mill Street Baptist Church, at Eminence, at 10 o'clock, A. M., on the above date, with Elder Grigsby in the chair. The Moderator read the 8th chapter of Romans, sang Hymn 646,

O, that I knew the secret place Where I might my God,

and prayer by Elder A. Heath. The organization was completed by Electing Elder S. Grigsby Moderator, Elder E. J. Anderson Secretary and Bro. Geo. Barbour Treasurer.

The following subjects were discussed:

Is is right for Ministers to solemnize the right of Marriage between divorced persons? It was decided that the marriages as found in Matthew 5, 36 and 19, 8, is a sufficient guide.

Subject 2nd—What authority have the Churches to refuse letters

to members in good standing? Decided they have none.

Subject 3rd—Is it right for Christians to dance? Decided it is not right from the following Scriptures: James 4, 4; Mark 6, 22-28; I. Cor. 4, 14; II. Cor. 6, 12; Rom. 8, 5-6.

SATURDAY MORNING, July 14.

Ministers and Deacons at 8:15. Moderator in the chair. Hymn 131,

Did Christ over sinners weep?

Prayer by the Moderator. Subject discussed, What is the sin unto death? Resolved, that the sin unto death as set forth in the Bible, as known presumptious sin, as indicated in such passages as Jer. 7, 16, 14; II. John, 17, 9; and Ex. 32, 10 and 7, 16.

Topic 4—What became of Judas Iscariot? Decided that he was lost, from the following Scripture, Mat. 26, 24; Luke 22, 22;

Acts 1, 16-19.

On motion, the officers for the ensuing year be elected by acclamation, Elder D. A. Gaddie was elected Moderator, Elder G. W. Ward Assistant Moderator, Elder E. P. Marrs Secretary, and Elder S. Mack Treasurer. The officers elect thanked the Association for the honors conferred on them. The Moderator, on taking his seat, delivered an address on Education and the duties of Ministers toward each other, that will long be remembered by those who heard it. After which he sang Hymn 13—"How sweet the name of Jesus sounds in a believer's ear." Prayer by Elder A. Heath. The

Clerk then read the Rules of Decorum and Constitution. The hand of fellowship was then extended to the members representing new Churches.

Elder R. Straus, the representive from Lexington District Extension Association, made a fine speech on Church Extension. On motion, Elder S. Grigsby, for his valuable services since the organization of the Central District Association, be made a life member. Bro. F. J. Buckley Annual member. On Motion, we adjourn to meet at 8 o'clock, P. M. Prayer by Bro. J. W. Harris.

The Association assembled at 8 o'clock, P. M. to hear the Intro-

ductory Sermon by Elder E. J. Anderson.

Bro. F. J. Buckley sang Hymn 852, "Go, preach my Gospel, saith the Lord," and offered prayer. Elder E. J. Anderson sang Hymn 1045, "And now my Soul another year of thy short life is passed." He then took his text Prv. 6th chapter, 6: Go to the ant, thou sluggard, and consider her ways and be wise. He said that his subject might be termed Christian Industry. The text was forcibly and logically handled, and is worthy of commendation.

After a few remarks by the Moderator, Elder Miller offered

prayer. Collection \$8 15. Benediction by E. J. Anderson.

THURSDAY MORNING, July 12, 1883.

The Association convened at 10 o'clock—Moderator in the chair. He opened by reading the 53rd chapter Isah, and sung Hymn 845, "Jesus is gone above the sky." Prayer by Elder P. Alexander. The reading of Letters was resumed. Minutes of the last session read.

The Committee on next annual Sermon report. (See report.)

The Committee on Correspondence report. (See reports.)

The Committee on Temperance made their report, and was laid over until three o'clock, P. M.

The Committee on Sunday Schools reported. (See reports.)

The Association stood adjourned, with prayer by Elder Allen Allenworth.

EVENING SESSION.

The Association assembled at 2 P. M. Moderator in the chair. Opened by reading the First Epistle of Paul to the Phillippians—Hymn 170: "No change of time shall ever shake my trust, Lord, to thee." Prayer by Elder J. M. Morton. Minutes of the morning session read and approved. Dr. Porter, of the White Baptist Church, and Elder Mason of the Christian Church, Dr. H. H. Hockens, Elder A. Allensworth and Bro. Wm. H. Steward were introduced to the Association.

The Committee on Ministerial Destitution made their report. (See report.)

This subject was participated in by the following Brethren: G.

W. Ward, W. Lewis, R. Straus, and others.

The hour of three having arrived, the subject of temperence was again taken up and discussed by a number of brethren.

The Executive Board made their report. (See reports.)

The Committee on next Annual Meeting reported, and recommended the Centenial Church, Louisville, and Pewee Valley Church, and Taylorsville Church. The vote was taken, and Taylorsville Church was selected for the place of the next meeting.

The Committee on College reported, and the report was laid over until to-morrow. The Association stood adjourned, to meet

at 8 o'clock, P. M.. Benediction by the Moderator.

The Association assembled at 8 o'clock, P. M. to hear a sermon by Elder C. C, Bates. Dr. B. A. Franklin read 12th Chapter of Paul's Epistle to the Romans. Hymn 274, "There is a fountain filled with blood, drawn from Emanuel's vains." Prayer by Dr. B. A. Franklin. Elder C. C. Bates took 22nd Chapter of Matthew, 4th verse, "All things are ready, come to the marriage." Subject—The Gentiles invited. Collection \$3 76.

FRIDAY MORNING, July 13, 1883.

The Association assembled at 10 o'clock, Moderator in the chair. He opened by reading and sang Hymn 85, "'Tis religion that can give." Prayer by Elder John Hatter. Minutes of the last meeting read and approved, except that part criticizing Elder Bates' sermon. The reading of Letters was contined.

The Committee on Periodicals report. (See report.) This report was discussed by Brothers Steward, Allenworth, Franklin and Straus.

The Committee on Circular Letter reported. (See report.) On motion, we return a vote of thanks to Elder Gatting and Professor Holling for their able remarks to the Association.

Resolved, that the appointing of the Missionary be left to the Ex. Board, and that they send out one or more. The Association stood adjourned, with prayer by Elder Gatting.

Geo. Barber became a life member of the Association by paying \$2 50.

EVENING SESSION.

The Association met at 2 o'clock. Moderator in the chair. He

read the First Epistle of Paul to the Thessalonians. Prayer by Elder A. Merefield. Minutes of the last session read and approved. Dr. Hall was introduced to the Association and delivered an address. The Committee on Resolutions continued their report. The Association adjourned at 3 o'clock, P. M., in order that the Sunday School Committee might convene, and reassembled at 8 o'clock, P. M., to hear a sermon by Elder Wm. Miller. He opened by reading the 23rd Psalm, and Elder I. Lamkins Hymn 1122, "And must this body die." Prayer by Elder Lampkins. Elder Miller then took his text: Zacheus come down, for this day I must abide at thy house. Subject—we are up two high; we must come down. The subject was skilfully handled. Collection \$7 95. Benediction by Elder Miller.

APPENDIX.

The Association assembled Saturday night, to hear a sermon by Elder R. Straus. He preached a good, practical sermon. At the conclusion a collection of \$4 50 was raised. On Sunday morning Elder A. Allenworth conducted the devotional exercises in the Sunday School at the church, and Elder J. W. Lewis preached. Elder D. A. Gaddie and Elder E. P. Marrs at the hall. Elder Gaddie preached one of his powerful sermons from Matthew 28, 19, Go ye, therefore, and teach all nations. Subject, you must 'be taught. Elder A. Heath preached in the afternoon at the hall and Elder O'Bannon in the afternoon at the church, and Dr. Franklin at the hall a night, and Elder Allen at the church.

We indeed had a glorious time during the sitting of the Association. On Sunday not less than three thousand people crowded into Eminence. They give to the Association \$46 oo. May the Lord bless the citizens of Eminence for the kind manner in which

they entertained the messengers of the Association.

CIRCULAR LETTER.

DEAR BRETHREN OF THE CENTRAL DISTRICT ASSOCIATION.—In writing this Letter, in compliance with my appointment, I find a profund pleasure, and a task which does me great honor. We have met, brethren, in our Thirteenth Annual Session; and as we meet upon this height, let us pause a moment and look back at the pathway along which we have come, that we may strengthen our faith and renew our hope.

Since our first meeting in Shelbyville, in 1870, with Brother Charles Clark as Moderator, this Association has been a power against the ignorance and sin of this district, and even the whole of Kentucky. Like the acorn, sinking, sinking deep in the ground, shooting forth and sending its branches high in the balmy breeze, in the form of the sturdy oak; this Association, from a small body of Christian brethren, planted in Shelbyville, shot forth and now towers in the balmy breeze of popularity, one of the strongest

Associations in Kentucky.

The work which it has done for the College is highly gratifying, and the Home Mission and Sunday School work, have received your closest attention. Excellent, indeed have been your past efforts, and much is the good that has been accomplished. Now, brethren, we shall gather fresh courage from the good results of our past labor, and from henceforth push forward with a determination to do everything with untiring energy to elevate our people and the cause of Christ, in Kentucky. Surely, brethren, the harvest is great, therefore none of us should stand idle, but we should go forth in

Then will the Baptists grow, and spread their arms over the whole of Kentucky, and great and general prosperity prevail.

Brethren, can you feel satisfied with your work as ministers of the Gospel, without a deep and active interest in the Sabbath-school, and the training of the children? You certainly cannot. When Jesus was here upon earth he said, suffer little children to come unto me, and forbid them not, for of such is the kingdom of heaven. Then we must suffer them to

come to Jesus through the Sabbath-shool. See?

If we neglect the Sabbath-school work, we neglect one of our most essential duties, as workers for Christ. Remember, dear brethren, that the

children are the future hope of the church.

In concluding, I would say let us ever fight to support our College and the American Baptist—which are strong helps to the Baptists of the State, and something of which we can justly feel proud. Let us support everything that is an enemy to ignorance and sin; and that will promote the cause of Christ.

Let us now, as We take the parting hand, say—If I have done nothing in the past, I will do that way no more; if I have done something for Christ, I will do just so much the more, and if I have drank whisky, wine beer in the past, I am determined never to touch any more.

See, dear brethren, if we part with such determinations, God will smile

upon us, and crown our labors with great success.

REPORT OF THE MISSIONARY.

DEAR BRETHREN: -- I beg leave to submit the following report, as your Missionary of the Central District Association.

I visited Grant County, having arrived at Crittenden, and finding a Baptis Church there, pastored by Elder Bush, belonging to the Consolidated Educational Association. I preached several sermons there, leaving there for Dry Ridge, and on arriving there I found there a few Baptist, I preach-

ed a few sermons and attempted to organize a church at that point. They informed me that they wanted a church, but Elder Bush, being the Missionary of the Education Association, had promised to organize a church for them,

consequently I failed to organize in that locality
Leaving Dry Ridge for Williams Town (the county seat of Grant,) I arrived there on Monday Morning, finding not one Baptist in the whole place, I at once sought a place to preach for them, finding two connections of Methodist there, it was very difficult to get a place to preach. They were in war, one against the other, having nothing but a school house to preach in, one party had rented the house, and were trying to keep out the other party. The house being owned by a colored man whom I stopped with, who seemed to have been a Baptist believer, went with me one night to the house to a meeting, which seemed to have been an officers meeting, I arose and introduced myself to the congregation, and made known my business as a Missionary of the Central District Association, and asked them the privelige of preaching for them, that I might have the people to hear me the next night. It was rejected saying it was their prayer meeting night, I also asked for the next night, and it was rejected being their class meeting night, at this point the gentleman whom I stopped with, arose to my resecue and said as I was rejected I should preach at his house on Thursday night.

Hearing that they agreed that I should preach there that night, and they would have nothing going on. The other preacher of the other connection being there, invited me to go with him to Corinth, Ky., to preach with him. So I went to the Depot and paid my fair and mounted the cars. Him and I arrived there that night and found his Deacon Steward very low, church being closed on that account. I failed to get to preach there, so I returned to Williams Town, and by that time I was out fifty cents and had done nothing. I then preached that night at Williams Town, to a good audience and they seemed to rejoice.

Leaving there the next morning for Owen County, I preached there at New Liberty, Owenton, Liberty Station, Carroll County and for Steven Creek, Gallitin County. I left there for Lagrange, to assist in preaching Brother Jack Fuller's Funeral, Brother Saultee, not being present, the funeral did not go on, and I preached that day in the Court House.

On the 4th, Sunday in September I preached again in Lagrange, I left there for Shelbyville, where I preached several sermons with Elder M. Allen, and left for Taylorsville, and from Taylorsville, to Mt. Eden, and there I preached and Lectured to the Sabbath School, and from there back to Taylorsvelle, entering into a series of meetings with Brother Mack.

Received at Beargrass Baptism, 13, Restored, Letter and Watchcare, 6, Total 19. Received by Baptism at Greencastle, 8, otherwise 3, Total, 11. Received by Baptism at Fifth Street, Louisville, 73, Restored by Letter and Watchcare 50, Total 123. Received by Baptism at Simpsonville, 9, otherwise, 12, Total, 21. Received by Baptism at Goose Creek, 8, Total for the year, 186 of which 117 were converts, and 65 were received otherwise.

Money received \$206.08, Sick Visits 28, Sabbath School Lectures 17, Funerals preached and assisted in preaching 10, Sermons preached 239,

Miles traveled 561.

REPORT OF THE EXECUTIVE BOARD.

To the Central District Association, when convened with the Baptist Church at Eminence, Ky., July 11th, 1883, Greeting.

DEAR BRETHREN:—We, the Executive Board, feel glad to submit our Annual Report. We feel grateful toward our Heavenly Father for his blessings toward us since our last sitting.

The churches in the district have enjoyed rich harvests of revivals, and many souls have been made glad in the grace of God. To God belongs all

the praise for this grand and noble work.

According to the work that was referred to the Board, at the last sltting, concerning the picture drawings of the college, the Board appointed a committee to see what 500 pictures would cost. When they reported, we found that we had not the money to have them drawn. The College, we learn, is in a very good working condition. The building is overflowed with students, and have not the room to accommodate them. Therefore the great demand is for money to pay for the property, and also that it may be more commodious.

Now the Sunday-school work. Sunday-schools are important for the young and idle on Sunday. Also many old people that do not attend Sunday-schools. There was appointed last year a District Sunday-school Superintendent, but the board has not heard of any schools the said superintendent has visited or none he has organized. We therefore recommend the association to see to it that the waste places are considered, and one be appointed that will take a deep interest in the Sunday-school work.

We cannot say much about our missionary work. We refer you to him for his report.

Elder S. Grigsby, our correspondent messenger to the Nelson County White Association was successful in receiving from said association \$63.55, donated to the Institute. His traveling expenses were \$6.10 from the above amount, which left \$57.45 that was forwarded to the Corresponding Secretary of the General Association. Yesterday, July 10th, Elder Grigsby turned over \$5 more for the same, which is in the hands of the Treasurer. The grand total turned over by him, \$68.50; expenses, \$6.10; clear of expenses, \$62.45.

SECOND SESSION, SATURDAY MORNING, July 14th, 1883.

In persuance to adjournment, the Central District Convention met in their second session, at 10 o'clock A. M., Saturday morning, President G. W. Ward in the chair. The meeting was opened by the Rev. Andrew Heath reading the nineteenth chapter of St. Matthew, and prayer by the same, and after singing, the minutes of the last session were read, and approved.

The committee on Sunday-schools submitted the following: We your committee on Sunday-schools recommend the establishment of Sunday-school institutes in all the counties of this district. We further recommend that the Convention employ the services of Rev. Allen Allensworth to establish and help conduct them in each county, and that they meet as often as possible during the year.

The Committee on Periodicals then reported, recommending the American Baptist and the International Series. The report was adopted.

After which the Convention adjourned to meet at 2 o'clock P. M.

THIRD SESSION, SATURDAY EVENING, July 14th, 1883.

The Central District Convention met in their third session at 2 o'clock P. M., President G. W. Ward in the chair. The session was opened by

Rev. E. P. Marrs reading scripture and offering prayer. After singing, the minutes of the last session were read and approved.

The Committee on Place of Next Annual Meeting submitted the following: We recommend that the Sunday-School Convention meet at Taylorsville, Kentucky, on Friday before the third Lord's Day in July 1884, with the Association, which was on motion adopted.

At this junction Bro. Allensworth made some remarks in behalf of the American Baptist Publication Society. A motion to take up a collection for the benefit of this society was carried. Collection \$3.05.

On motion Bro. F. J. Buckley was appointed Superintendent of the Sunday-Schools composing this Convention.

Miss Mary E. Hughes then came forward and read a very able Essay, subject, "Pernicious Reading." It was moved that this essay be published in the American Baptist. Carried.

After singing and prayer the Convention adjourned to meet at Taylors-ville on Friday before the third Lord's Day in July 1884.

ESSAY-SUBJECT: ON SUNDAY-SCHOOL WORK.

It is good for us I think in this era of Sunday-schools and Sunday-school triumphs, to consider the blessings that have flowed from them, just as it is well for the man in business, once-in-a-while to draw off his ballance sheet, so that he may see his profits and resources. So it is well enough for our encouragement, to stop a moment and ask what the Sunday-school work done for the Church, this will be done very briefly.

- r. The Sunday-school has added to the membership of the church. It has been and is a most valuable institution, the large majority in all our children have come into the church out of the sunday-school. In the Sunday-school, the teachers are preachers, and our children are intended hearers and the word of God, brought in such sweetness, agreeable with the soul that it brings forth its fruit most abundantly. The Sunday-school has done and is a great work for the church, every year adding numbers of its members to the church, such as are saved.
- 2. It has added to the intelligence of the church, not only has it enlarged its membership, but a work as muchly needed, has been done by the steady measure of intelligence of the churches, and this measure of knowledge, may be traced direct to the Sunday-schools. There is a noble amount of ignorance now, and the Sunday-school has not yet done its full work. But steadily the good work is going on, and the tree of knowledge and the christianizing influences of the Sunday-schools, is growing larger and larger in all our churches.
- 3. It has added to the workers of the church, there are so few in our church who are willing to work, there are fewer still who know how to work. The Sunday-school is aiming to supply the great demands of the church and is gradually succeeding, and all the children are being sent into the church as trained and efficient laborers.
