Constitution of East Union Association.

ARTICLE 1. This body shall be called East Union Association of United Baptist, and shall be composed of churches of the United Baptist faith and order.

ART. 2. Each church composing this body shall be entitled to representation, with one vote for every twenty members, or frac-

tion thereof.

ART. 3. This body shall meet annually according to agreement

ART. 4. This body, at each annual meeting, shall elect, by private ballot, a Moderator, Clerk and Assistant Clerk, whose

duties shall be such as custom imposes on such officers.

ART. 5. The business of this body seall be for the advancement and growth of Christ's Kingdom among all the churches of this body or elsewhere. Planning and advising and using all lawful and necessary means in our power to build up new churches and building them up in the most Holy faith.

ART. 6. This body shall exercise no ecclesiastical authority.

ART 7. This body may appoint a committee to carry out or

perform any business under Article 5.

ART. 8. This body shall be constituted by and with messengers and delegates from the different churches belonging to this Association.

ART. 9. New churches will be received by a vote of the delegates present, upon approved evidence of their United Baptist

faith and principles. A majority rules.

ART. 10. Visiting brethren of same faith and order will be invited to seats with us, and allowed the liberty of speech, but not to vote.

ART. 11. The Constitution may be altered or amended, except Article 6, by concurrence of two-thirds of the members present, after notice having been given at its previous annual meeting.

ART. 12. No member shall speak more than twice upon any one subject without leave of the Association. Chairmen of committees are given ten minutes, all others five, unless time is ex-

tended by the Association.

ART. 13. Members wishing to speak shall arise and address the Moderator with brotherly respect, and await recognition from him, and then speak. Any brother, having received recognition from the chair, is entitled to the floor undisturbed, while his five minutes lasts, if he does not digress from the subject on which he is speaking. Members shall call no brother by any other appellation than that of Brother.

ART. 14. Any brother may arise to a point of order, if any brother digress from the subject on which he is speaking, question

of privilege.

ART. 15. A motion with a second is before the Association for action, unless another is made to amend, then the amendment is for action, afterwards the original.

ART 16. No member shall absent himself from the house

during the business hours, without leave of the Moderator,

ART. 17. All whispering and laughing strictly forbidden dur-

ing business hours.

ART. 18. Two members arising and addressing the Moderator at the same time, both claiming the floor, the one farthest from the Moderator shall be entitled to the floor first and the other next.

ART. 19. This Association may withdraw its fellowship from any church in its bounds for a violation or departure from the

United Baptist faith and practice.

ART. 20. The Chair, having decided any question which is thought to be contrary to the constitution of United Baptist faith, any brother may appeal from his decision to that of the house.

ART. 21. On each morning at the opening of the Association there shall be given one hour, or such less time as is necessary, to the offering of resolutions and such new business as is necessary.

ART. 22. If the Moderator fails to exact the rules of this Constitution in the transaction of business, any member of this Association may move him to order, if he fails to exact such rules, the Assistant Moderator shall take the Chair.

It is ordered that this Association adopt Mell's Parliamentary Practice for our guide in the transaction of the business of our

REPORT ON FOREIGN MISSIONS.

We, your committee, beg leave to make our report: Our work in Africa is wonderful in results, baptisms 355. In China we have 88 missionaries; baptisms 710. Japan, Baptisms 42. Brazil, baptisms 866. Italy, baptisms 121. Mexico, baptisms 137. Grand total, 2,231. Increase over previous year, 155 baptisms. State of Kentucky increase of giving to offerings, \$339.49. Total contributions \$25,258.37. Now then how much did we give of this amount? The State Board asks for an increase in giving to the amount of \$3,000 in Kentucky this year

COMMITTEE ON HOME MISSIONS.

We, your Committee on Home Missions, beg leave to make the

following report:

The territory is vast; the numbers crowding our cities of the South and West will require a great effort on our part to meet them. Let us do something in this great work; according to the

statistics given by the Southern Baptist Cenvention, the amount expe ded by the Home Mission Board in Kentucky amounts to \$3,-179.25. That amount emoraces the money appropriated to Mountain schools and to agency expenses, as well as for the support of the mission work reported. The cash receipts of the Home Board the last year were \$169,988,92; of the above amount Kentucky gave \$14 295.58 in cash, which was an increase of more than 67 per cent. in five years, besides the cash contributions reported and included i, the Minutes of the General Assaciation.

We further recommend that our churches give more liberally to the Home Mission work; that their giving should be so liberal as to embrac the emigration We further recommend that the colored man of the South should not be neg'ected. We strongly recommend our Home Field, published by the Board, which is filled

with Mission rry reading.

REPORT ON SUNDAY SCHOOLS.

We. your Committee, offer the following report:

We believe that early imp essions made by the word of God are the most lasting, and the way to get such impressions as are calculated to benefit and elevate our children, is to be found in the Sunday-school. We have no reason to be discouraged over the report of the East Union Association on Sunday-schools, for the last year. There might be room for do bt as to whether all has been done that might have been done, but this does not in itself imply a reason for discouragement. The figures indicate a very hopeful outlook. According to the report, out of the eleven churches reported seven reported Sanlay schools, with an enrolment of 515 . . . only four churches of those reported are left without Sundayschools. A little concentrated effort would, no loubt, bring about similar resu ts in these. We would recommend that every church. not now maintaining a Sunday school, organize and carry on one throughout the year; or a part of the year if not convenient for all for the benefit of the children, because we believe there are more people brought to Christ through this or racization than any other part of the work of the church.

It is a detriment to everything that is good and great and grand; it is a foe to the school, to the church and to the State at large, and distress, poverty and crime are itsillegitimate offspring. It is the blight of childhood, the heartbreak of motherhood, the restlessness of fatherhood, the shame to manhood, and, worst of all, the gateway to hell. The Christian world is aroused and prompted at last, that the saloon must go, |Temperance measures are pressing to the front in every civilized country. We call your attention to the fact, as did your committee ast year, that the Legislature of Tennessee has passed measures whereby almost the entire State has been freed from this great evil, and its good effects are easily seen by us on the border. We hope our State, Kentucky, will awaken to a sense of duty and justice and pass such measures in the near future as will remove the curse from our great State. We plead with every Christian voter throughout the bounds of our Association to support only such men for office whose pers nal preference, character and records constitute an irreversible guarantee that their official services will promote temperance reform. We also advise that the pastors of the different churches press the cause upon the people. We further urge that the churches do not tolerate dram drinking as a beverage by their members.
