Constitution of East Union Association.

ير بر بر

ARTICLE 1. This body shall be called East Union Association of United Baptists, and shall be composed of churches of the United Baptist faith and order.

- ART. 2. Each church composing this body shall be entitled to representation with one vote for every twenty members, or fraction thereof.
 - ART. 3. This body shall meet annually according to adjournment.
- ART. 4. This body, at each annual meeting, shall elect, by open ballot, a Moderator, Clerk and Assistant Clerk, whose duties shall be such as custom imposes on such officers.
- ART. 5. The business of this body shall be for the advancement and growth of Christ's Kingdom among all the churches of this body or elsewhere. Planning and advising and using all lawfull and necessary means in our power to build up new churches, and building them up in the most Holy faith.
 - ART. 6. This body shall exercise no ecclesiastical authority.
- ART. 7. This body may appoint a committee to carry out or perform any business under Article 5.
- ART. 8. This body shall be constituted by and with messengers and delegates from the different churches belonging to this Association.
- ART. 9. New churches will be received by a vote of the delegates present, upon approved evidence of their United Baptist faith and principles. A majority rules.
- ART. 10. Visiting brethern of same faith and order will be invited to seats with us, and allowed the liberty of speech, but not to vote.
- ART. 11. The constitution may be altered or amended, except Article 6, by concurrence of two-thirds of the members present, after notice having been given at its previous annual meeting.
- ART. 12. No member shall speak more than twice upon any one subject without leave of the Association. Chairman of committees are given ten minutes, all others five, unless time is extended by the Association.
- ART. 13. Members wishing to speak shall arise and address the Moderator with brotherly respect, and await recognition from him, and then speak. Any brother, having received recognition from the chair, is entitled to the floor, undisturbed, while his five minutes last,

if he does not digress from the subject on which he is speaking. Members shall call no brother by any other appellation than that of Brother.

ART. 14. Anv brother may arise to a point of order if any brother digress from the subject on which he is speaking, question of privilege.

ART 15. A motion with a second is before the Association for action, unless another is made to amend, then the amendment is for action, afterwards the original.

ART. 16. No member shall absent himself from the house during the business hours, without leave of the Moderator.

ART. 17. All whispering and laughing strictly forbidden during business hours.

ART. 18. Two members arising and addressing the Moderator at the same time, both claiming the floor, the one fartherest from the Moderator shall be entitled to the floor first and the other next.

ART. 19. This association may withdraw its fellowship from any church in its bounds for a violation of departure from the United Baptist faith and practice.

ART. 20. The Chair, having decided any question which is thought to be contrary to the constitution of United Baptist faith, any brother may appeal from his decision to that of the house.

ART 21. On each morning at the opening of the Association, there shall be given one hour, or such less time as necessary, to the offering of resolutions and such new business as is necessary.

ART. 22 If the Moderator fails to exact the rules of this Constitution in the transaction of business, any member of this Association may move him to order, if he fails to exact such rules, the Assistant Moderator shall take the Chair.

It is ordered that this Association adopt Mell's Parlimentary Practice for our guide in the transaction of the business of our Association.

REPORT ON STATE MISSIONS.

By State Missions we mean the efforts put forth by the General Association through its Board to save souls and build up the Baptist cause in the destitute parts of our own State. While there are two hundred thousand and more white Baptist in Kentucky many of them are doing little or nothing directly to aid the General Association in its great work. Much of the destitution in the State is in our own mountain section and at the same time we have a great many Baptist in this section. Our mountain brethren for many years past have been isolated from our people in other sections of the State and also uninformed upon the great work of our denomination. These conditions are rapidly changing; railroads are penetrating our mountains in every direction and developing our vast resources and Baptist schools are being planted everywhere. We Baptists of the mountains are now becoming well to do financially and some rich, and our children are rapidly becoming educated. God is therefore calling us here in the mountains to take our stand by the side of our brethren in the other parts of the state, to push forward the work of State Missions.

The General Association maintained in Kentucky last year, 78 missionaries, 12 colporters and 4 or 5 evangelist, these received into the churches by baptism, letter and relation 2289 members. The State Mission Board received for State Missions last year \$14,585.16 which was \$3500 more than the previous year, H. H. Hibbs and W. M. Golden, Committee. Discussed by H. H. Hibbs.

REPORT ON FOREIGN MISSIONS.

The Foreign mission work is a living issue at present, urgent demand appeals to our liberality. 1st 'From a plain command of our Savior. 'Go ye into all the world and preach the gospel to every creature.'

Here we have a plain three; saith the Lord.

1st, To preach the gospel.

2nd. To every creature. 3rd. To all the world.

That person claiming to be a Baptist who cannot see a command from his Lord in the above words to aid in giving the gospel to his

fellows or the Foreign field is in my honest judgment criminally ignorant and will have a fearfully sad account to give in a coming day.

Again I insist that a Baptist who claims that it is not his duty to give, and libarally divide his income in helping to give the gospel to the perishing millions of the earth who now are in heathen darkness without the gospel and hence without God and must of necessity, be eternally lost, if we fail to give it to them, is not worthy of the name Baptist.

We wish therefore to beg and urge with all our people, and every man or woman who wishes to ware the name of Baptist, to make a weekly or a least a monthly offering to our Foreign Mission work. Why not rise up and make an earnest and persistant effort to get every member of our churches to give something if it be but a small amount to this work. Committee I. Lawson and A. F. Baker.

HOME MISSIONS.

The Home Mission Board of the Southern Baptist Convention located at Atlanta, Ga., has under its charge mission work in all the South and also in Cuba. The Home Board also has as part of its work the founding and maintaining of Baptist Schools in the mountain sections of the South. The Williamsburg Institute and also the Barbourville Institute have been aided for several years. This Board maintained last year 880 missionaries and these missionaries received into the churches, 27,614 members by letter and baptism. The Board received from all the States in the bounds of the Southern Baptist convention last year \$167,899.88 which was \$30,000 00 more than fhe previous year. Committee H. H. Hibos and J. M. Our Baptist Orphan's Home in Louisville, Ky., still continues successfully in the good work of caring for the needy orphans of the State. The new matron Miss Mary E. Abercrombie has introduced several

improvements which add to the efficiency of the home

The children of this home are being sent to the Public School and

are being taught and made efficient in sewing and cooking. We find that 110 orphans were cared for during the past year.

This home is supported largely by the free will offerings of the people, we therefore, urge upon the brethren and sisters throughout the East Union Association to continue to increase their contributions of clothing, eatables, etc., the incoming year.
We recommend that a cash collection be now token.

REPORT ON TEMPERANCE.

We the Committee on Temperance beg leave to report as follows:

We believe the subject of intemperance is one of vital interest, and in fact we believe the liquor traffic in our state and country is the greatest evil that confronts the cause of Christ to-day. The liquor traffic antagonizes every effort for goods, in church, state or nation, and is the direct producer of distress, poverty and crime. It is the blight of childhood, the shame of manhood and the fountain of heartaches for the mothers and wives of our land, and the destroyer of the soul.

We are glad to call your attention to the fact that the Christian world is beginning to wake up and be aroused to their duty and are pressing temperance measures to the front in every religious and civilized land.

We call your attention to the temperance law which our last legislature of Kentucky passed known as the County Unit Law, which gives the people a vote by county, as to the sale of liquor within their border. This law was brought about by agitation and the passing of many resolutions of religious bodies and in response to thousands of prayers of our wives and mothers. We are glad to say this law brings the responsibility of the sale of liquor in the future in our own County and lays it at our feet. "The ax is laid at the root of the tree." Who will be the first to take it up and strike the fatal blow to the liquor traffic in old Whitley County?

It is easy to see the good results in our border state, Tennessee, where the saloons have been driven out never to return.

We all call your attention to the fact that under the Tennessee temperance laws, the people have moved the saloon out of every town and city in the state except 12 and their days are numbered.

An election is to be held in Whitley County under the County Unit Law on the six of next December.

Therefore, be it resolved that it is the sence of this body to urge

our preachers to preach temperance from the pulpits and urge all Christians to work and vote as never before and carry the temperance election which is now on.

STATISTICS OF SUNDAY SCHOOLS.

Report of twelve churches, only 5 churches report Sunday Schools—Pupils 417—money contributed \$176 05. Seven churches report show no Sunday School at all, and a falling off of 250 pupils. Therefore we recommend that all the churches take charge, organize and maintain a Sunday School.

REPORT ON EDUCATION.

It is with pleasure that we report upon the two schools represented in this association that both of them, the Williamsburg Institution, and the Barboursville Baptist Institution, have just passed through the most prosperous year of their history. Last year the school at Barboursville enrolled 268 pupils and employed five teachers. The Williamsburg Institute enrolled 618 pupils and employed fourteen teachers.

The Williamsburg Institute had completed at the opening of school January 1906, a \$20,000 domitory for boys which was immediately filled to overflowing. The glrls domitory was full and many were turned away for lack of room.

Recently through the efforts of Rev. H. H. Hibbs, the Williamsburg Institute received a gift of \$40,000, with which to build a new recitation building.

In the state the outlook of Baptist educational affairs is very incouraging. Last June, at Richmond, the day before the meeting of the General Association of Kentucky Baptist representatives of most of the Baptists schools in Kentucky met an organized the Kentucky Baptist Education Society. No school is compelled to join this society,

but any Baptist school may do so by accepting the provisions of the charter of the society.

At this meeting it was decided to raise \$500.000 for Baptist schools in the state. Dr. Gatliff started the subscription by the extraordinary gift of 4000 acres of coal land. valued by experts at not less than \$100,000.

Dr P. T. Hale has just been elected corresponding secretary of this society and will soon begin an active campaign to raise the \$400, 000 on the raising of which Dr. Gatliffs gift is conditional. Let all Baptist smile and say that by the help of God this great work shall be carried through in a triump befitting our great denomination.
