# CONSTITUTION

OF THE

## General Association of Baptists in Kentucky.

ART. I. This body shall be called the GENERAL ASSOCIATION OF KENTUCKY BAPTISTS.

ART. II. The payment of Thirty Dollars constitutes a Life Membership. Annual Members may take seats upon the payment of One Dollar. Churches and Associations auxiliary to this body, by contributing to its objects annually, are entitled to representation.

ART. III. It shall be the duty of every member to obtain leave of absence before leaving the Association, and the Secretary shall give no certificate of membership to a member who has not this leave, or who does not remain until the adjournment of the meeting.

ART. IV. The business of this body shall be to promote State Missions; also the Home and Foreign Mission Work under the Boards of the Southern Baptist Convention; also Bible and Book Colportage, Sunday-Schools, and Literary and Theological Seminaries in the State; and to collect and preserve our denominational history in Kentucky.

ART. V. This body shall exercise no ecclesiastical authority.

ART. VI. The body shall, on meeting annually, elect by private ballot a Moderator, two Assistant Moderators, and a Secretary and Assistant Secretary, whose duties shall be such as custom imposes upon their respective offices. They shall hold their offices until superseded by successors.

ART. VII. At each annual meeting the body shall appoint an Executive Board consisting of fifteen members (five of whom shall constitute a quorum) to conduct its business during the intervals between its annual meetings. They may appoint a Treasurer, a Corresponding Secretary, an Agent or Agents, and Missionaries and Evangelists; shall fix and pay their salaries; and report their doings annually to this body. They shall be competent to fill vacancies in the Board.

ART. VIII. Visiting brethren may be invited to seats in our annual sessions.

ART. IX. The body shall meet annually according to adjournment.

ART. X. This Constitution may be altered or amended (except Article v) by the concurrence of two-thirds of the members present.

## ORDER OF BUSINESS.

I. Call to order by the Moderator of the last session ; or, in his absence, by either of the Assistant Moderators ; or, in their absence, by the Secretary or Assistant Secretary. If all be absent, a Moderator and a Secretary *pro tem.* shall be called by motion.

II. Appointment of Committee on Enrollment and Credentials.

III. Election by private ballot of a Moderator, two Assistant Moderators, and a Secretary and Assistant Secretary.

IV. Reading of the Constitution and Order of Business.

V. Upon each morning, at the opening of the business, one hour, or such less time as may be necessary, shall be devoted to the introduction of resolutions and such other business as is not provided for in the regular order.

VI. Appointment of Committee on Divine Service.

VII. Appointment of Standing Committees, to report during the sessions in the order of their appointment, as follows :

1. Committee on State Missions.
2. Committee on Foreign Missions.
3. Committee on Home Missions.
4. Committee on Sunday-Schools.
5. Committee on Religious Periodicals.
6. Committee on Kentucky Baptist History.
7. Committee on Colleges and Schools.
8. Committee on Nominations.

1. Report from the Corresponding Secretary.
2. Treasurer's Report.

IX. Appointment of the time and place of next annual meeting.

X. Selection of the preacher for the next annual sermon.

13. J. P. Boyce read the following report as Agent for the Endowment of the Southern Baptist Theological Seminary :

THEOLOGICAL SEMINARY.

The General Agent for the endowment of the Southern Baptist Theological Seminary, as to the Kentucky portion, begs leave to present to the General Association the following report:

The agency has been prosecuted during the past year to the full extent that could profitably be done. Rev. Jos. E. Carter continued his valuable services until the first of October last, when he resigned in order to engage in evangelistic work. Rev. G. W. Given has continued up to this time, and will still continue. Rev. A. B. Cabaniss has also been engaged, and commenced his work on the first of May, of this year (1878).

The total amount of bonds, subscriptions, and lands secured up to the 1st of May, was \$269,569 61. This does not include the tract of land, valued at \$15,000, which, though given in Kentucky since the undertaking of this endowment, was not given to it; and by the desire of the donors, is not to be accounted a part of the endowment raised to secure the \$300,000 for bringing the Seminary to this State.

Leaving this out of consideration there would, if the bonds had all drawn interest from September, 1872, as was originally intended, still remain to be raised the sum of \$30,430 39. But the bonds which have been given ought not to be counted at their full value because they have not borne this interest, and moreover, because it is probable that at least \$20,000 of the subscription bonds and land is no longer good.

Your agent would recommend that the Association fix at this meeting the amount of bonds and subscriptions, such as have been taken and are now taking, which it will tender to the trustees of the Seminary, as a full compliance with the amount of \$300,000 originally proposed to be raised.

Upon the bonds which have been given, there had been collected in cash, to April 1st, \$62,277 87. The total cost of the endowment collection to that date was \$25,713 54, leaving a net amount of \$36,564 33, which has gone to the credit of permanent endowment. Of this sum, \$22,920 43 has been collected during the past twelve months.

Your agent requests to say that very few persons have complied with the suggestion of the General Association, at its last meeting, to pay up their bonds in full. The result may prove very embarrassing to the Seminary, as the permanent fund must be invested, and can not be used for current expenses, and the fund which was raised for this purpose in the other Southern States, was only intended to cover the period of time ending October 1st, 1878. As this fund was a donation from the other States over and above the amount promised by them for endowment, in order that the Seminary might be sustained while the Kentucky endowment was collecting, it would seem but a proper responsive act, if Kentucky can do something in the same line for the coming two or three years, until the whole endowment shall have been completed.

14. W. M. Pratt read the Report of the Executive Board :

REPORT OF THE BOARD.

I.—FINANCES.

The books of the Treasurer show a debt of \$2,109 79, June 1, 1877, that was to be paid out of the collections of the year. There has been collected this year, \$4,463 89, and at the present session of the Association, \$574 75, making in all \$5,038 64.

When these subscriptions are paid our debt will be canceled.

## II—LABORS OF MISSIONARIES.

Rev. J. J. Edwards, Winston, is one of the oldest missionaries in the employment of the board. He has traveled more miles, preached more sermons, and baptized a greater number than any other missionary of the General Association. He has been quite feeble for the last few months, and unable to do his accustomed work. He reports as having been actively engaged 134 days; traveled 1,350 miles; preached 134 sermons; made 112 pastoral visits, and received 57 additions to the Church. He has organized one church in Clay county. In concluding the report of his year's labor, he remarks: "While much labor has been done, there yet remains a large amount of labor to be done in the mountains."

Elder Jesse Tyree, Mt. Vernon. This brother, under appointment of the board some two years ago, in connection with Elder N. B. Johnson, established a church at Brodhead, Rockcastle county. He has been greatly blessed in his labors at this point. A meeting-house has been erected and regular worship maintained. We give the report of his year's labor at this place in his own language: "I have preached two Sundays and one Saturday in each month; one protracted meeting of 18 days; traveled about 240 miles; labored 45 days; preached 36 sermons; delivered several exhortations; received into the church 13 members—8 by baptism and 5 by letter. The church is in a very healthy condition. They have grown slowly, but substantially, and number 51 members. They have a Sunday-school the year round, and most of the time a weekly prayer-meeting. The prospects are favorable of this being one of the strongest churches in the mountains."

Elder I. W. Bruner, Hodgenville, was appointed some eighteen or twenty months ago, to endeavor to establish a church at New Haven, Nelson county, on the Lebanon railroad. After one year of effort he writes, November 29, 1878: "I am thankful to the board for their confidence in me in appointing me their missionary at New Haven. I worked a year there as faithfully as I could. I had a pleasant and encouraging congregation; raised an equivalent to a good cash subscription of \$2,000 for a meeting-house. But notwithstanding the many favorable circumstances connected with the work there, the leading object in view is a failure, to-wit: a meeting-house and a church organization. It fails for want of faith and interest in the cause." Brother Cabaniss visited the place the last of the year, and found one influential friend of the cause had died; another was about moving to Louisville; others faint-hearted about undertaking the work, and as brother Bruner had tendered his resignation, the board thought best to discontinue the mission there. I have no report of the particulars of brother Bruner's labors.

Elder John T. Casebier, Rockport, was appointed to preach, and endeavor to secure the building of a house of worship at Rockport, Ohio county, at the June meeting of the board. He says in his final report: "We commenced the year by meeting once a month in a house used for church and school purposes, two other denominations occupying it once a month, each. Our new house of worship was commenced last September. It was a good frame building 38 by 50 feet, costing \$1,200. The congregations, since we have been occupying it, have been large and attentive. In December I held a protracted meeting of 19 days and nights. There were 25 conversions; 23 have been baptized, and 14 have joined by letter. The present number of the church is 84; increase of the church during the year 34. Since January we have had a Sunday-school every Lord's day, and a weekly prayer-meeting. I have preached 58 sermons and attended 20 prayer-meetings; traveled 100 miles, and made a good many pastoral visits. The outlook of the church seems, at present, to be encouraging."

Elder J. B. Wood, Tunnel Hill, Hardin county, reports 67 days labor; 67 sermons preached; traveled 200 miles; 27 baptisms; received 8 by letter. He sent his resignation to the board the last of November.

Elder Andrew Jackson, Bedford, was appointed last year to devote a por-

tion of his time at Milton, Trimble county. He resigned in February, having labored some nine months. He has not reported in full—only stated: “The appointments have all been filled; congregations good and attentive. I was compelled, at our last meeting, to resign as pastor at Milton. They failed by a considerable amount, to pay me what they promised, and I get very little from the board.” He reports 14 additions by experience and baptism.

Elder H. L. Dietz, German missionary, Louisville, has been laboring here for two years. Both his predecessor, Elder Henrich, and himself denominate it “a hard field.” There has been a debt upon the church property of about \$1,500; and brother Dietz, in addition to his missionary work, has endeavored to obtain means to lift that debt. His own church has raised \$700 towards it; a concert at Broadway netted \$100 more; and he mentions brother Junius Caldwell, of Walnut Street Church, as having rendered them valuable assistance in obtaining contributions for them. He thinks, by the time of our annual meeting, they will have succeeded in getting rid of this incubus, as there is now but \$150 lacking. He says, “My work is State, Home, and Foreign Missions all combined. I have preached 114 sermons; held 130 other meetings; made 400 pastoral visits. Our Sunday-school has 12 teachers and 80 scholars.”

Elder H. Gellert, German missionary, Newport, took charge of the small German interest in this place some two and a half years ago. He wrote to the board in June, to endeavor to have his salary, of between \$300 and \$400, supplemented by the Campbell County Association. Brother Cabaniss visited the Association and obtained \$126 55, and some few individuals voluntarily gave \$72 60, so that he has been able to sustain his family. He says, June 28th, “When I took charge of the church it numbered 26 members; it now numbers 52—just double, in 18 months; I baptized 20 of these.” He reports in February 12 baptisms, and several others deeply interested. One particular feature of the church is “we have a weekly prayer-meeting and ALL our members pray in public.” They have also an “interesting Sunday-school, averaging 100 pupils, and prospects very encouraging.”

Elder J. M. Frost, Jr., Lexington, pastor of Upper-Street Baptist Church, has received assistance from the board for six months during the Associational year, when this vigorous church became self-sustaining, and no longer needs your aid. Brother Frost, in his last report, states that in the month of October the church dedicated her new house of worship to the service of God, since which the congregations are more than twice as large as formerly, and the present outlook is indeed encouraging. The house cost, including the lot, \$11,250, the whole amount of which has been paid, except about \$900, which is provided for in what we consider good subscriptions. Brother Frost preaches twice every Lord's day; has baptized in the six months, 5; received 12 by letter, and the church numbers 117. She sustains a good Sunday-school and weekly prayer-meeting.

Elder Cleon Keyes, North Fork, reports as follows: “I give you a report of my labors in Cynthiana (county seat of Harrison county), from the beginning of my services there, fourth Sabbath in August, until the 1st of May, some eight and a half months: Sermons preached, 38; prayer-meetings attended, 24; prayer meetings addressed, 16; family visits, 167; received by baptism, 1; received by letter, 3. The church has hitherto been distracted by difficulties which has seriously retarded its growth and prosperity. The condition, I think, is decidedly more hopeful. Our congregations are generally good, the prayer-meetings are well attended, and the Sunday-school gives greater promise of life and usefulness than heretofore.”

Elder J. H. Fullilove, Big Clifty, Grayson county, was appointed last May, as missionary at West Clifty Church. Their meeting-house had burned down, and they requested the modest sum of \$50 for the year, to help sustain their pastor, while rebuilding the house of worship. Brother F. has visited various churches in the interest of this church, and donated his salary from the board to help rebuild their house. The church sustains a prayer-meeting and a Sunday-school during the summer. The brethren have collected material, procured a

suitable location, purchased lumber, and will soon, by God's blessing, be in their new house. Brother F. has traveled 300 miles; preached 40 sermons, and baptized 5. "The brethren are few in number and poor in purse, but occupy a promising field."

Elder John N. Hall, Fulton, Ky. Fulton is a town of 1,500 inhabitants, in the extreme south of Kentucky, at the crossing of the Paducah & Memphis and the New Orleans, Chicago & St. Louis railroads, and the attention of the board has been directed to this as an important place for missionary labors. The church numbered but 35 members, and they were unable to sustain a pastor without assistance. Brother Hall took charge of the church last January. He resides about twelve miles distant, at Martin, Tennessee. He writes: "Fulton is a hard field. The Methodists and Campbellites largely predominate, and our brethren are much disheartened. They have been slow to come up to the work, but the prospects are brightening now. We have the best regular congregation in town, have secured a lot as a building site, and the promise of 50,000 bricks toward building a house of worship. Sermons preached, 14; temperance addresses, 3; Sunday-school addresses, 2; received 3 by letter; organized a Sunday-school—40 scholars, 4 teachers; visited nearly every family in town."

Elder N. B. Johnson, Waco, has supplied the church at Crab Orchard one Sunday in the month; the remainder of his time was employed in missionary work, and collecting. He reports: Days of labor, 308; miles traveled, 1,580; sermons preached, 240; exhortations delivered, 50; received by experience and baptism, 48; received by relation, 10; received by letter, 8; restored, 6; families visited and prayed with, 90; Sunday-schools organized, 6; Associations visited, 4; Sunday-school papers distributed, 500; tracts distributed, 600; collections for the board, \$405 80.

#### SUMMARY.

Thirteen Missionaries. Number days, 1,200; number miles traveled, 4,000; number sermons preached, 871; exhortations and addresses, 75; pastoral visits, 997; prayer meetings, 244; baptized, 200; received by letter, 69; churches constituted, 1; meeting-houses built, 1; Sunday-schools established, 9.

### III.—SUPERINTENDENCY OF MISSIONARY WORK IN THE STATE.

At the last meeting of the General Association, the board was advised "to appoint a General Superintendent of our entire Missionary Work in the State, such as State, Home, and Foreign Missions and Sunday-schools; that he be a man of executive ability to take the supervision of the entire field, making such arrangements with the agents respecting the different interests of the Baptist denomination in the State, and with pastors, churches and Associations, by correspondence, or otherwise, for raising funds for these various objects as he shall find practicable; whose duty it shall be to aid in so arranging our missionary operations, as to prevent the friction and collisions we now have under our present plans; said Superintendent to act under the direction of the State Board."

In pursuance of this advice the board, at its first meeting, elected Elder W. W. Gardner to this office. On the 2d of July, Brother Gardner accepted the appointment, but before the month ended, for reasons satisfactory to himself, tendered his resignation, which was accepted.

Elder A. B. Cabaniss, who for six years had been your Corresponding Secretary, was continued in that office, when he, also, resigned. He very kindly offered to continue for two or three months, to collect for the board, without charge, save for his necessary traveling expenses. This he has done, as much as the state of his health would permit, until the first of May, when he entered upon the duties of another agency. Brother Cabaniss has been a hard-working and an honest agent. He has accounted promptly and satisfactorily for all the money that has passed through his hands, and deserves and possesses the implicit confidence and affectionate regard of his brethren and acquaintances.

Near the close of last year the board elected Elder Wm. M. Pratt as Superintendent. After due consideration he expressed his unwillingness to resign the pastoral office and devote himself exclusively to this work. He proposed, however, to devote a portion of his time, until the meeting of the General Association, to the duties of this office, with the especial view of freeing the board from its debts. The Superintendent has corresponded with churches and brethren throughout the State, and made appeals through the "Recorder," to secure voluntary contributions to this end. There are enrolled about forty churches which have pledged aid without the visit of an agent. Some few of these have done well. It remains to be seen how much the rest will send up to the Association. The voluntary contributions were so few, we deemed it best to employ Elder S. F. Thompson for some six weeks, at a moderate salary, to solicit contributions. He has done exceedingly well. Brother Cabaniss had gone over the field so generally, that there were left but very few churches to visit; otherwise, we might have secured enough to wipe out the entire debt. It should be our policy to induce churches which are interested in the missionary work, to attend to the matter of raising money for this object within themselves; to adopt some system; to request their pastor to preach upon the subject and give them all the information available to him; to appoint their own collectors and forward the several amounts to the treasurers of the different boards. In this way churches will form habits of systematic beneficence, become increasingly interested, and the expense of an agency saved. It will probably be some years before our churches will be trained to attend to this matter as they should.

Brother Gardner stated to the board in his letter of resignation, "of the 1,250 Baptist churches in Kentucky, 1,157 have only monthly preaching, and *no system of benevolence can be effective in them.* Of the remaining 97, thirty-five have preaching every Sabbath; three have preaching three times a month; fifty-nine have preaching twice a month, and thirty-eight have adopted a system of their own and dispense with agents. Of the 97, fifty-nine need to be organized and systematized."

This is not a very flattering aspect of the missionary spirit and enterprise of our churches. If it was left to voluntary action on the part of churches to sustain our missions, probably not more than one in twenty would make a respectable contribution. We are not prepared, at present, to dispense with a collecting agency. Not only churches must be visited, but individual members at their homes, and personal application made for assistance to carry on our missionary enterprises. The visits of a suitable agent are a great blessing to the churches. He should be thoroughly informed respecting the mission he represents, and give the people definite and full information. He should preach as often as opportunity presents and his strength will permit a pure gospel unto them, and move them to contribute from motives of love to God and for the salvation of men. The heavenly influence of such men as Elders John Peck and Alfred Bennet, who in former years visited this State in the interests of Home and Foreign Missions, was long felt among the churches, and old brethren, even now, often speak of those godly men. O, that their mantle of piety and zeal might rest upon us as ministers and agents.

#### IV.—THE RESPECTIVE WORK OF THE DISTRICT AND GENERAL ASSOCIATIONS.

The District Associations should utilize the capabilities of their own members as much as possible, in evangelical, Sunday-school and colporteur work within their respective bounds. If, instead of limiting their transactions to the stereotyped routine of business, inquiries were raised respecting the best means of advancing the cause of Christ in their midst, and pledges be given of voluntary labor, in one way or another, on the part of the members of the body, great good would result from such action, as is manifest in the Elkhorn and other associations that have taken this "new departure" during the last year.



Neither churches nor individuals should look to Missionary Boards for help when they have sufficient ability within themselves. The pastors of the churches could and would do a vast amount of missionary work within the limits of their Associations, if their brethren would invite their attention to this or that neighborhood, and would co-operate with them. Our young men and women of the Church would do much in the Sunday-school work if they were encouraged to do so. The fact is, brethren attend the Associations with expectation of meeting their brethren, hearing good preaching, enjoying the hospitalities of the church where they assemble, forming new acquaintances, and having a good time generally, but without any particular thoughts or projects in their minds about enlarging the borders of Zion in their midst. The occasion of these assemblies should be devoted to earnest discussion pertaining to the interests of Christ's Kingdom, more especially within their own bounds. The lack of interest in the State mission work of our General Association, arises from lack of interest in District Associations respecting supplying the destitution within their own borders, and the lack of interest here is referable to the lukewarm state of our churches, and still further back, to the indifference of pastors and leading members of the churches. What Paul said in his time, "All seek their own and not the things of Jesus Christ," is applicable to a very large proportion of our members, and even some ministers of the gospel. There is scarcely zeal enough in our church to develop the energies of her own members, and there is a deplorable lack of this in our District Associations.

The object of the General Association is to help the weak, and to occupy vacant territory; to be the medium of united effort on the part of Missionary Baptists throughout the State; in endeavoring to establish churches at county seats and important centers of trade and influence, where there are no such churches; to promote evangelistic and itinerant labor where it can be usefully employed, and also to counsel and aid in the Home and Foreign Missionary work; to promote our educational interests, and the circulation of our periodical and other religious literature. The annual meetings should be attended by brethren and sisters representing churches and associations from every part of the State, and these important occasions should be devoted to making arrangements for doing much and effective work in our Master's vineyard during the year. Your Missionary Board is but your agent to carry out, during the year, your behests. To afford the board the means of prosecuting State missions successfully, she should be advised of important and destitute fields needing laborers; the most suitable persons to occupy such places; and the churches throughout the State should contribute liberally to her treasury, for the support of those who may be appointed. The board will practice the strictest economy in the collection and appropriation of the funds contributed.

#### V.—SUNDAY-SCHOOL DEPARTMENT.

On account of the indebtedness of the board at the beginning of the year, our obligations to the men in our employ and the smallness of contributions, and also not knowing whom to select as Sunday-school missionaries, the board has not, until recently, done anything in this department. Three young men of the Theological Seminary have been appointed as Sunday-school missionaries and colporteurs, during the four months of their vacation, and we purpose to appoint a fourth one.

Bro. J. A. Campbell, a graduate of Georgetown College, and who is taking a theological course, has been appointed for Union county, and his base of operations will be at the Shotwell mines, near Caseyville.

Z. W. Wilborn has gone to Albany, and will work in Clinton and Wayne counties.

R. E. Johns, who has finished his theological course, will go to Pulaski county.

We think it will be highly advantageous to these young brethren, as well as promotive of Sunday-school interests, to employ theological students, during their vacation, in this work.

## VI.—FOREIGN AND HOME MISSIONS.

The General Association is auxiliary to the Southern Baptist Convention, and feels an abiding interest in the prosperity of her missions.

The agent of the Foreign Mission Board, Elder R. L. Thurman, has prosecuted his agency very successfully during the year, considering the cry of "hard times" that is heard in all directions, and reports over \$5,000 as collected by him in Kentucky for the Foreign Mission Board.

Elder V. E. Kirtley is the agent of the Home Mission Board. His collections amount to over \$2,600.

This board, besides appointing a number of missionaries in the States, has under her direction one Indian mission. This has been very prosperous. The churches should contribute steadily to help sustain Foreign and Home Missions.

## VII.—INSTITUTIONS OF LEARNING.

Georgetown and Bethel College, and our various seminaries of learning, both male and female, have been very well attended during the year. The instruction in them all has been increasingly thorough for the past few years. The financial state of some are not so healthy as they ought to be, but we believe the interest of our people in these institutions of learning will secure their needful endowment when the times are more favorable.

Probably the grandest achievement of Kentucky Baptists is in securing the location of the Southern Baptist Theological Seminary at Louisville, in this State. The General Association has been consulted, and her action requested, at every step of this removal and endowment. The first year's success in its new location, is exceedingly gratifying. Ninety students were enrolled, and they have pursued their studies with diligence. The teachers are men eminent for learning, and have devoted their energies to thorough instruction.

## VIII.—THE BAPTIST ORPHANS' HOME.

The Baptist Orphans' Home is a well managed institution. Its Board of Managers is composed of wise and pious men and women. The matron and teachers are devoted to the interest of the children committed to their care. They unite wholesome, moral and religious with literary instruction, and most of the larger children have made a public profession of their faith in Christ. This institution has strong claims upon our sympathy. The various churches throughout the State should make, at least, an annual contribution for its support.

## IX.—THE WESTERN RECORDER.

The "Western Recorder" is still published by our worthy brother, Dr. A. C. Caperton, and is an excellent religious periodical, and is deserving the patronage of the denomination far more than it has received.

In conclusion, the past year has been one of great financial embarrassment. All our benevolent institutions have felt this very seriously. Your board has done the best it could, and its members all feel deeply interested in the prosperity of the General Association of Kentucky Baptists.

#### REPORT ON HOME MISSIONS.

The Home Mission Board has under its control that department of missionary work which has for its field the destitute parts of the Southern States and the Indian Territory. This field is as important as it is extensive. Many of these destitute districts must remain without the preaching of the gospel, unless supplied by this agency, since no other board proposes to operate in them. The history of the board's past labors is encouraging. The work accomplished, in its bearing upon the Kingdom of Christ, has been of immense value. Many places once destitute have, through the labors of its missionaries, become centres of influence, and are now sending forth the gladdening streams of salvation. Kentucky Baptists have ever been foremost in the support given this board, and have each year contributed liberally to its funds. During the past year, notwithstanding the financial embarrassments of the country, Kentucky has given to this work nearly \$2,700 of the \$12,000 contributed. Our efficient agent, Rev. V. E. Kirtley, has devoted about nine months and a half to the work this year, having visited one hundred and forty-three churches and ten associations, preached and lectured before Sunday-schools, prayer-meetings and churches whenever opportunities presented themselves. He has organized

missionary boards in the mountains, and raised funds for the building of a church in Somerset. He has traveled about 7,000 miles in the prosecution of his work. Thus it will be seen that, all things considered, the work of the present year has been equal to that of any year of the past. By retrenchment, the board is now free from debt, which is cause for gratitude to God.

We, as a committee, recommend the earnest and constant co-operation of the pastors, churches and associations with our agent, Rev. V. E. Kirtley, who has just entered upon his third year of this agency, and has thus far met with great encouragement.

#### REPORT ON SUNDAY-SCHOOLS.

Your committee recognize the subject of the report as one of permanent importance to the cultivation of vital piety among the people of God, and to the glory and honor of our blessed Saviour in the world.

The Sunday-school of the present day carries with it the idea of Bible study, and the knowledge of the true God as revealed in His Word, is the only remedy ever formed adequate to the ills common to human life. Again, the truths of the Bible and the Christian graces springing up with a knowledge of these truths, constitute the soil from which all true vital godliness must grow. In vain does the farmer prepare the ground and sow the seed, unless the gentle showers and warm sunshine send their fructifying influences; so all our efforts to build up the vigorous, symmetrical, spiritual life by outside appliances and associational machinery only, must end in chagrin and disappointment. God has imposed upon His people, in all ages, the duty of studying His words and teaching them to their children, and to the strangers within their gates. Up to this time the only plan presented to us for the systematic study of the Bible among the whole people, is in the Sunday-school. If these things be so, the question naturally arises, Who should be interested and engaged in the Sunday-school work? We answer, every professed follower of our loving Savior. Of whom should the Sunday-school be composed? All lovers of Jesus, and all who need the grace of God in their hearts. One year ago this body abolished the Sunday-school Board, and referred the work in this department to the General State Board. Owing to financial pressure and other causes, the Board was able to report but little work done since our last meeting. They have made a few appointments for work during the summer months, which we hope will result in much good. We recommend that a committee of three be appointed by this body, to co-operate with the State Board in procuring the services of some brother to devote all his time to the Sunday-school work, and that said committee try to raise funds to sustain said Superintendent.

At a very small expense, "the weekly paper brings into the family the best thoughts of some of the best minds." In its essays, sermons, Bible expositions and current editorials, it affords to the careful reader an amount of religious knowledge not so readily obtained through any other channel, while it also acquaints us with the plans and workings of God's people, thus aiding very materially in arousing the energies and securing the co-operation of the brotherhood.

Your committee therefore indorse the recommendation of the General Secretary: "The Western Recorder, which is still published by our worthy brother, Dr. Caperton, is an excellent religious periodical, and is deserving the patronage of the denomination far more than it has received." We would also recommend to the brethren and sisters, The Orphan's Friend, published in Louisville, Ky., designed to awaken and maintain the sympathies of the people in behalf of the Orphan's Home. As a good Sunday-school paper, we also recommend "Kind Words," published by the Home Mission Board, in Macon, Georgia.

The Foreign Mission Journal, published by the Foreign Mission Board, in Richmond, Virginia, will be found one of the best means of kindling and keeping alive our missionary zeal.

Ford's Christian Repository, published in St. Louis, Missouri, now passing through its twenty-fifth volume, being the only Baptist monthly on the continent, is recommended as furnishing good and varied reading, denominational and general.

#### REPORT ON ORPHAN'S HOME.

Whatever may be said of other interests in our State, your committee feel constrained to say the Orphan's Home deserves your most earnest and liberal consideration.

An institution for the care of helpless orphan children is one of the grandest and most praiseworthy a people can establish and maintain; and now that the work of endowing the Seminary is about through with, we believe the benevolence of our brethren and friends should be appealed to for the endowment of this Home.

We can not enter into a discussion of the propriety, here and in this report, of the necessity of the endowment of this institution, with a view of giving a more extended education to the children, and providing for them until they are properly indoctrinated in our principles, but merely state the hope that the work will be at once put on foot in some proper way. The Home has received, since the last Association, thirty-one children; sent out thirty-five; had returned five; one death; twelve, from the age of 12 to 15 years, have joined the church, and others are interested.

There are eighteen children in the nursery, from one and a half to five years of age. There are sixteen boys, making in all under seven years of age, forty-six, total number at the Home.

The students of the Seminary have generally conducted religious services with the children. Notwithstanding the tightness of the times, the Home has been very fairly supported during the past year, and with the usual and desired increase of effort, the support the year to come will be abundant, and happiness and prosperity will attend it.

#### COMMITTEE ON THEOLOGICAL SEMINARY.

The committee to whom was referred the report of Dr. Boyce, as the General Agent for securing the Kentucky portion of the endowment of the Theological Seminary, beg leave, respectfully, to recommend the adoption of the following resolutions:

1. *Resolved*, That we appreciate the confidence in Kentucky Baptists, shown by the Trustees of the Seminary in removing the institution to this State, prior to the actual completion of the Kentucky subscription to the endowment; that we gladly welcome its faculty and students among us, and rejoice that its first session in Kentucky has been attended by one-third more students than at any time before.

2. *Resolved*, That the General Association of Kentucky Baptists reappoint Dr. J. P. Boyce as its General Agent in this matter, and direct him to continue the effort to raise the additional sum of \$15,500, for the endowment of the Southern Baptist Theological Seminary, so as to complete the sum of \$300,000 from Kentucky; and that when this sum of \$300,000 has been secured in cash, in real estate, and in such bonds and subscriptions as have been taken and are now being taken, this be tendered to the Trustees of the Seminary as a substantial compliance with the proposal of the General Association of Kentucky Baptists.

3. *Resolved*, That as the principal of the endowment can not be encroached upon, we recommend that Kentucky Baptists bear their share of the current expenses of the Seminary, while the effort is made to secure the subscription of the whole endowment.

#### REPORT ON FOREIGN MISSIONS.

Your Committee on Foreign Missions would make the following report:

"Go ye into all the world and preach the gospel to every creature," was the commission given by our Saviour to his disciples. The lands in which Christianity now prevails were brought beneath the sway of the Christian religion by ministers of Christ who, carrying out the commission, bore the gospel to heathen lands. We owe to the missionary spirit our earthly civilization and our hopes of heaven; and the commission calls upon us in acknowledgement of the blessings conferred upon us to send the gospel to other lands lying in heathen darkness. The Foreign Mission Board of the Southern Baptist Convention has established mission stations in Africa, in China and in Italy. In Africa are Brethren David and Colley, with several native assistants. In China the Board has as Missionaries T. P. Crawford, Mrs. M. F. Crawford, Mrs. S. J. Holmes, Miss L. Moon, M. T. Yates, Mrs. Yates, R. H. Graves, Mrs. Graves, Miss Lula Whilden and eighteen native assistants. In Italy the Rome Mission has spread abroad its influence and has taken possession of Naples, Venice, Milan, Modena and other important points. In this field Brother Taylor is laboring, assisted by nine native assistants. Three native ministers have been raised up during the year, 32 baptisms have occurred and over 50 hopeful inquirers are reported. In Rome a chapel has recently been purchased at a cost of \$25,800, which is favorably located upon one of the great thoroughfares of the city. The hand of Providence in opening up China and Italy to missionary effort points us to those lands especially as fields upon which to expend endeavor. The Foreign Mission Board is represented by Bro. Thurman, well known to all of us as its agent in our State. The Board also desires that ladies' missionary societies may be organized in our churches for the purpose of raising funds for its benefit. We should also state that \$6,000 are needed for the mission chapel at Rome, toward which amount the Board asks that \$1,000 be raised in Kentucky; and a number of our brethren agreed at Nashville to make an effort to raise that sum in the State. In all these channels of benevolence we recommend the Foreign Mission Board to the hearty co-operation of the Baptists of our State.

#### REPORT OF COMMITTEE ON COLLEGES AND SCHOOLS.

Perhaps there never was a time with us when there was a more pressing demand for education than there is at this present time. We have made advances, but there are other most important advances to be made. We need an educated ministry; we need an educated membership as well. If we could lift the masses of our people to a higher plane of intellectual cultivation, we would also lift them to a higher plane of usefulness and power in the kingdom of our Redeemer. That "knowledge is power," was never more palpable than it is to-day. Whether sanctified or unsanctified, still, "knowledge is power." If, therefore, we would rise up to the measure of our responsibility and wield the utmost of our influence for good upon the world, we must aim at the highest education of the greatest number of our people. We boast, and sometimes in an unseemly manner, of the magnitude of our numbers. That God has given us power with the masses is, on one hand, pleasant to think of, and on the other, shame. For the question arises, what are we doing with these masses, and what for them? If they were a well-drilled, earnest, developed army for Christ, then the world could hardly withstand them. But they are not, and our aim should be to make them such as far as practicable. There are two things which should be especially aimed at: First, to awake an enthusiasm among the people upon the subject of education, which will lead the youth to particularly desire the benefits of education. Second, to enlarge as soon as practicable our educational facilities. Institutions of learning we have, equal to any others in the State, but their power might be greatly increased by an increase of their endowments and general appliances. We learn the following facts concerning our colleges:

#### GEORGETOWN COLLEGE.

Georgetown College is sustaining itself under all the financial pressure of the times. The number of students was somewhat diminished this year from what it would otherwise have been by reason of the prevalence of scarlet fever in the town; but notwithstanding this scourge, reached the number of 98.

The effort to increase the accommodations for boarding students at cost has been only suspended, not relinquished, and we trust will be renewed before the opening of the next session. At present there are arrangements for boarding about thirty at cost, say \$2.50 a week, exclusive of fuel.

#### BETHEL COLLEGE.

Bethel College, during the current year, has matriculated 127 students, 19 of whom are studying for the ministry. The N. Long Hall has been in successful operation, and the trustees and faculty feel that the problem of furnishing cheap board to all students is now practically solved. Over 70 students have been boarded and lodged at \$10 per month, thus largely diminishing the expenses of the patrons of the college. The entire expense of attending this institution, including board, lodging, fuel, lights, washing, books, &c., is \$97 for



term of five months. As heretofore, licentiates and sons of active ministers pay no tuition, and hence their expenses are for same time \$67. For the next five months 15 licentiates will be assisted from the income of the Enlow Fund to the extent of \$20 paid on the board of each in the N. Long Hall, reducing their expenses to the nominal sum of \$47 for five months. As published in present catalogue the curriculum has been extended by adding a year to the course formerly required in Greek, and also by providing for instruction in a commercial school. To meet this additional demand on the faculty, arrangements have been made to add by the opening of next term another instructor.

The committee has also had its attention called to

FLAT GAP HIGH-SCHOOL,

of Enterprise Association. It occupies a central position, and promises to do much for the cause of education in the mountains. We heartily indorse Bro. Jayne, the principal, and commend this academy to the liberality of our churches. The committee desires to call attention to the fact that we have a number of institutions of learning, for the special education of young ladies, and some of them are of great merit.

REPORT ON STATE MISSIONS.

The report of your board shows an encouraging amount of work done for the amount of money collected and expended. The expenses have been very much curtailed and very satisfactory, all things considered. A sufficient amount having been obtained to pay off all the missionaries, and liquidate the old debt of over \$2,000. We rejoice that we are able to enter a new year free of debt, provided all the subscriptions are paid.

The board procured the services, last winter, of a Superintendent, whose efforts have contributed largely to these results. It is very desirable that the board should secure the services of a proper one, to devote as much of his time as may be agreed upon between him and the board as desirable, to correspond with churches in order to induce them to adopt a system of benevolent action, to visit associations and as many churches as it is thought agreeable to further the ends; to make arrangements with the agents of the different societies to alternate in their canvass of the State, so that a church be visited by agents not oftener than once in three months, and to attend to other matters deemed advisable by the board.

We also commend the views of the board, in their annual report, respecting the work of the District and General Association working to their development and usefulness.

## REPORT OF THE CENTENNIAL COMMITTEE.

The work of the committee during the year has been limited to gathering up the fragments, that nothing be lost.

The accompanying report of the Treasurer shows that \$1,231.88 have been collected during the year, making the whole amount that has passed through the hands of our treasurer, \$12,664.65; which amount, after deducting expenses of collection, has been disbursed as directed by the donors, or as provided for in the distribution of undesignated contributions.

A considerable sum in subscriptions and notes, some of which are not yet due, is still uncollected.
