## VIEWPOINT

By NATHAN C. BROOKS, JR.

GREETINGS AND BEST WISHES to the former students and graduates of Carver School of Missions and Social Work! As your new President I covet the privilege of renewing fellowship with those of you whom I have known before. And as for those of us who have not yet gotten personally acquainted, I trust that we will get to know each other before too long.

LET ME ASSURE YOU of several things in connection with our leadership here in Louisville:

1. THE ACHIEVEMENTS OF THE PAST WILL BE CONSERVED. I know that many have labored long and lovingly in other days. We shall accept as a precious heritage those things which they have wrought.

2. We will make every effort, by the grace of God, to see to it that CARVER SCHOOL IS SECOND TO NONE IN ITS FIELDS OF SERVICE. That means faculty additions, the recruitment of God-called, capable students, a new library, accreditation, scholarships, and above all, your prayers. Please keep in mind that we are not trying to imitate the seminaries. Ours will be a specialized ministry as we try to prepare workers for the mission fields, for denominational responsibilities, and for various phases of service as Christian social workers.

3. We pledge you that ALL THAT WE UNDERTAKE WILL BE DONE FOR THE PURPOSE OF HONORING CHRIST. Evangelism, Christian nurture, missions, and stewardship will be at the heart of our ministry.

YOUR HELP IS NEEDED in guiding qualified students to Carver. Our teaching is especially designed to prepare workers to serve under the Home Mission Board and the Foreign Mission Board. We propose to prepare personnel for service through Good Will centers, camps, homes for the aged, children's homes, hospitals, and in church-related social work.

YOU CAN ALSO SERVE well in helping us to inform the denomination about Carver. Several things that we want to get across to Southern Baptists are:

1. Carver is a separate institution owned by the Southern Baptist Convention and operated by a board of trustees elected by the Convention. It is not organically connected with Southern Seminary.

## Meet the New President

Dr. Nathan C. Brooks, Jr., was elected President of Carver School of Missions and Social Work in a meeting of the trustees on May 20 in Houston, Texas.

Dr. Brooks' election came in time for him to be presented to the alumni in their breakfast meeting in Houston the following day. On May 22 he was presented to the entire Convention in its morning session, where he spoke briefly of his aspirations for the future of the school, as "second to none in its fields of service."

The 46-year-old president comes to his new post from the pastorate of the First Baptist Church in Pensacola, Florida. Prior to his ministry there he served in the following churches: Broadway Baptist, Knoxville, Tennessee, 1934-35; Bryson City, North Carolina, 1935-36; First Baptist Church, Waynesboro, Georgia, 1943-46; Earle Street Baptist Church, Greenville, South Carolina, 1946-51; and Emmanuel Baptist Church, Alexandria, Louisiana, 1951-53.

From 1937-43 he was Training Union Secretary for North Carolina Baptists, and in 1942 served as Acting Student Secretary in that state.

Dr. Brooks' name appears frequently as a contributing writer for the **Baptist Adult Union Quarterly**. He is an occasional writer for **Open Windows**, **The Baptist Training Union Magazine**, **The Sunday School Builder**, **Baptist Young People's Union Quarterly**, and **Home Life Magazine**.

Other denominational activities have

included Chairmanship of the North Carolina Radio Committee, Secretary of the Southern Baptist Radio Commission, Trustee of the Alexandria Baptist Hospital. He served as a member of the General Boards for Baptists in South Carolina, Louisiana, and Florida.

His civic interests have included the Advisory Board for the Juvenile Court in Pensacola and the State Board of Mental Health. During his pastorate in Greenville he was president of the Community Council there.

During the past year Dr. Brooks served on the Board of Trustees for Carver School and as Chairman of the Trustees for Baptist Bible Institute in Graceville, Florida.

Dr. Brooks is a graduate of Wake Forest College and holds the master-of-theology degree from Southern Baptist Theological Seminary in Louisville. He has done graduate work at Columbia University and at Union Theological Seminary in New York City. In 1957 Wake Forest conferred the Doctor of Divinity degree on him.

Mrs. Brooks is the former Ruby Hayes, a 1934 graduate of Carver School (W. M. U. Training School). Also a North Carolinian, she was graduated from Mars Hill and Meredith Colleges.

There are five children in the Brooks family; Mary Kelly, 23; Nathan III, 21; Frank, 12; George, 9; and Misa, 8.

The Brooks family moved to Louisville June 18 and are living in the residence purchased for the school in 1953 at 2739 Lexington Road.



## Thanks To The Interim President

Mr. George A. Carver was named **ad interim** president of Carver School during the May 6 meeting of the trustees in Louisville. He served in that capacity until the election of Dr. Nathan Brooks in Houston.

Since January 1 the administrative affairs of the school had been handled by a committee of the faculty. Mr. Carver and Dr. Hugh A. Brimm had alternated months as chairman of the committee.

Mr. B. L. Williams, Chairman of Trustees, sent the following expression of appreciation for Mr. Carver's leadership:

"In behalf of all the trustees, I would like to commend Mr. George Carver for serving so willingly and efficiently as **interim** president of Carver School of Missions and Social Work. We are fortunate to have Mr. Carver on our teaching staff and appreciate all he is doing in behalf of missions and for our school. He has a great missionary vision and purpose which strengthens the witness of Baptists around the world."

## Concerning The Booz, Allen and Hamilton Survey

Since the Southern Baptist Convention took ownership and control of the Carver School of Missions and Social Work in June, 1957, two major steps have been taken by the trustees: 1) a planning survey has been authorized to be made by Booz, Allen and Hamilton, management consultants; 2) a new president for the school has been named who is committed in principle to the survey findings.

Here are some of the things discovered or recommended by Booz, Allen and Hamilton in their report:

1) Trained workers are needed constantly by the institutions and agencies which Southern Baptists have established to help them "to bring men to God through Jesus Christ." (Children's homes, homes for the aged, hospitals, rescue missions, good will centers, camps, assemblies, etc.) There is a growing and unmet need for adequate training for such workers. A minimum of seventy persons a year are needed now, "exclusive of the requirements on home and foreign mission fields, and outside the denomination."

2) No college, university, or seminary among Southern Baptists offers a graduate program of study leading to the professional social work degree. It is

not expected that any of the seminaries will enter the field.

3) The denomination's needs for persons well-trained in social work and advanced and specialized missions training can best be met if Carver School of Missions and Social Work continues, improves, and expands its present program. Since it is the denomination's only school of this kind it has special responsibilities to do outstanding work.

4) To afford the training needed Carver School must achieve full accreditation. This is being sought initially from the Southern Association of Colleges and Secondary Schools. It will be sought later from the Council on Social Work Education. In the process, the possibility of a future working affiliation with Georgetown College will be explored.

5) Three graduate degrees will be offered: a Master of Science in Social Work (M.S.S.W., 3 years); Master of Arts (2 years with a major in missions); Master of Arts (2 years with a major in church social service).

6) Three other programs will be offered by the school:

a. A research program of an applied nature

b. An undergraduate program, offering 60 units of senior college work, leading to a bachelor degree (essential for accreditation)

c. Special denominational service (summer training programs for institutional employees, assistance in schools of missions, participation in in-service training and orientation programs for missionaries, etc.)

7) The program at Carver is being projected to graduate 60 students a year by 1963, 90 by 1970, with a total enrollment of 150 full-time students by 1963, and 200 by 1970. For 150 students a full-time faculty of 10 will be needed, exclusive of the president and the librarian, plus 10 to 12 part-time faculty members.

8) While Carver School is completely independent of Southern Baptist Seminary, their adjoining campus locations call for cooperative agreements in many areas to effect economy in operation. Discussions to this end are underway.

9) Such a unique program to meet a specialized need in the life of the denomination will call for increased support to meet required growth in both capital investment and annual operating expenditures. The projected program will be presented to the Southern Baptist Convention Executive Committee this year.



# Alumni Meet in Houston

Alumni of the Carver School of Missions and Social Work gathered in the Crystal Room of the Rice Hotel in Houston, Texas, on Wednesday morning, May 21, 1958, for their annual meeting. Mrs. Walter L. Robertson, Jr., vice-president, presided over the session at which there were one hundred twenty-eight alumni and guests.

The alumni of Houston had decorated the tables in a motif of green and gold, with nets of gold spread under vases of greenery in the center of each table. The Rev. Nathan Brooks, trustee of the school, led the invocation. A beautiful program leaflet in gold and carrying a duplicate of the cover of Miss Littlejohn's "History of Carver School of Missions and Social Work" was at each place.

After the breakfast, Mrs. Robertson (under the caption of "Whither?—Their Love Embraced the World) recognized foreign and home missionaries present and each of them brought greetings. Other guests were recognized and Miss Norma Jean Baker presented to the group Mr. Clifford Sanford, president of the student government for 1958-59.

The secretary read a message from Mrs. A. T. Greene, Jr., expressing her regret at not being able to attend the meeting. The group instructed the secretary to send messages to Dr. Emily Lansdell, Mrs. A. T. Greene, Jr., and Dr. Hugh Brimm.

The presiding officer expressed appreciation to Miss Mary Christian for assisting with the program covers and to the Houston alumni for their help in arrangements.

Under the caption "Whence?—A Venture of Faith" a skit arranged by Kathryn Abee Greene and based on parts from Miss Littlejohn's book on the history of the school was presented. As the various principals were depicted students attending the school under their leadership were recognized. The skit closed with the entire group singing "Lead On, O King Eternal".

Mr. George Carver spoke on "Now . . . Whither?" and told of the progress being made at Carver School of Missions and Social Work. He stated that more than 4,000 students had attended the school, that 1930 had received degrees, and 420 missionaries had received some of their preparation there. Mr. Carver presented the newly elected president, the Rev. Nathan C. Brooks, who spoke briefly on the challenge in the future of the school.

The benediction, with the caption "Whither?—O God, Send Us Forth" was led by Miss Littlejohn, and concluded the program part of the meeting.

At the opening of the business session the secretary made a motion that the group dispense with the reading of the minutes since they had been published in the Alumni Bulletin. Motion carried.

In the absence of the treasurer, Miss Norma Jean Baker presented that report. Miss Baker stated that funds have not been such that would care for the expense of the Alumni Bulletin. After a discussion of the possibility of requesting the school to publish the bulletin, Miss Hannah Reynolds made a motion that if the alumni finds that it cannot finance the publishing of the bulletin that it seek other means of doing it. Motion carried.

Miss Edwina Robinson, chairman of the committee to bring suggestions relative to honoring Dr. Emily Lansdell, brought the following recommendations:

1. That the Alumni Association present a portrait of Dr. Emily Lansdell to Carver School;
2. That the Alumni be made aware of this project through the Alumni Bulletin; and
3. That in addition a letter from the Alumni president regarding this be sent to Alumni since 1951.
