MINUTES

OF THE RED RIVER ASSOCIATION OF OLD REGULAR PRIMITIVE BAPTIST

FRIDAY MORNING, SEPTEMBER 9, 1927

The Association met pursuant to adjournment. Áfter singing and prayer by Elder S. A. Amburgey, Elder W. L. Kash preached the introductory sermon from Timothy 4:16, after which the messengers assembled at the church house to transact the business of the association. After singing and prayer by Elder B. F. Robertson, letters and messengers from different churches composing the Red River Association were read and seated as shown in the table of statistics.

By motion and second Elder Noah Creech was chosen Moderator,

M. V. Bates, Clerk, and R. E. Thomas, Assistant Clerk.

By motion and second letters from new churches were called for and

none responded.

By motion and second letters from sisters associations called for. Burning Spring Association came forward with a letter by the hands of the following brethren: Elder K. K. Spencer and Bros. W. W. Elam, J. H. Elam and Millard Ferguson. A letter from Rock Spring Association by the hands of Elders W. B. Tacket and L. Conway. A letter from New Liberty Association by the hands of Elder B. F. Robertson. A letter from Spencer Association by the hands of Elder P. R. Hobbs, B. F. Miller, Joseph Creech and Bros. J. W. Whisman. Corresponding Messengers were given the right hand of fellowship and seats with us.

Motion and second that we call for letter from associations not in cor-

respondence with us of the same faith and order. None responded.

By motion and second transient ministers called for. None responded. Our next Association will be held with the Baptist Union Church, Wolf county, Kentucky, beginning Friday before the second Saturday in September, 1928.

By motion and second the Moderator make all temporary appointments. He appointed a committee on Arrangements as follows: Elder Jeff Brewer, J. F. Powell, S. A. Amburgey, H. D. S. Helton, Hewey Trent, H. C. Hurst and T. E. Wise, same to be committee on preaching and to report tomorrow at 9 o'clock.

Committee on Preaching named Elders Jasper Creech and K. K. Spencer this afternoon and Elders Jeff Brewer, W. B. Tacket and S. A. Amburgey, Saturday morning and Elders S. B. Creech and L. Conway

afternoon.

Motion and second to appoint Brethren to write letters to sister association as follows: Elder W. L. Kash to Burning Springs Association, Elder Jeff Brewer to Rock Spring Association, Elder H. D. S. Helton to New Liberty Association, Elder J. F. Powell to Spencer Association.

SATURDAY MORNING SEPTEMBER 10, 1927.

The Association met pursuant to adjournment. Prayer by Elder W. L. Kash.

Roll call. Messengers present.

Report of committee call for, read, received and comittee discharged. The Moderator appointed M. V. Bates and R. L. Thomas Finance Committee to see to printing 500 minutes and distributing of same and to make the following report:

ginning Friday before the third Saturday in August, 1928. Letter given Elder W. L. Kash.

Elder Jeff Brewer came forward with a letter to Rock Spring Association, read and received. Eider S. A. Amburgey, Adam Creech and Bro. R. L. Thomas agreed to bear same to this Association when convened with New Hope church, Rowen county, Ky., beginning Friday before the fourth Saturday in August, 1928. Letter given to Elder S. A.

Elder H. D. S. Helton came forward with a letter to New Liberty Association, read and received. Elders S. A. Amburgey, W. L. Kash, J. F. Powell, Noah Creech, S. B Creech and Bros. R. L. Thomas, H. C. ARTICLES OF FAITH

From a long series of experiences, we the churches of Jesus Christ, being regularly baptized of immersion upon profession of our faith in Christ, are convinced of the necessity of a combination of churches, and agree to keep up the rules of our Association according to the following form of government, viz:

Article 1. We believe in only one true and living God, Father, Son and Holy Ghost, equal in essence, power and glory, yet there are not three

Gods but one God.

Art. 2. We believe in the testimony of the Word, of the Old and New Testaments; is the true written word of God and the only rule of faith and practice.

Article 3. We believe in the fall of Adam and the imputation of his sin to his posterity, the corruption of his nature and the total inability of man to recover himself, either in part or in whole.

Article 4. We believe in election according to the foreknowledge of God, the Father, through sanctification of the spirit unto obedience and

the sprinkling of the blood of Jesus Christ.
Article 5. We believe that sinners are justified in the sight of God only by and through the righteousness of Jesus Christ imputed to them. Article 6. We believe that the saints will finally persevere in grace to

glory, and not one of them shall be finally lost.

Article 7. We believe that there will be a resurrection of the dead both of the just and unjust and that the happiness of the righteous and the punishment of the wicked will be eternal.

Article 8. We believe that the Church of Christ is a congregation of faithful believers in Christ who have obtained fellowship with each other and have given themselves up to the Lord and to one another and have agreed to keep up a godly discipline, according to the rules of the gospel.

Article 9. We believe that Jesus Christ is the head of the church and that the government thereof is upon His shoulders.

Article 10. We believe that true believers are the only fit subjects

of baptism, and that immersion is the only mode.

Article 11. We believe that the Lord's Supper and the washing of the saints' feet are ordinances of the Lord and are to be continued by the church until His second coming.

Article 12. We believe it to be the duty of the churches thus united collectively or individually to remonstrate against any doctrines or opinions of men that does not comport with the principles of this constitution, and if they fail to do so, shall be considered a violation of this Constitution.

Article 13. This Association shall withdraw from any church that acts or persists contrary to the principles of this Constitution.

Article 14. No church shall be received into this Association unless

they subscribe to this Constitution.

Article 15. All matters coming before this Associataion shall be decided by the will of the majority except the receiving or dismissing of churches and corresponding with other Associations which shall be done by a unanimous vote.

Article 16. This Association shall be governed by a regular decorum

This done and signed by order of the Association.

RULES OF DECORUM

Article 1. The Association shall be opened and closed by prayer.

Article 2. A Moderator and Clerk shall be chosen by the sufferage of the members present.

Article 3. The Association thus formed shall be a Council of Advice

and not an authorative body.

Article 4. The Moderator shall be deemed a judge of order, and

shall have the right at any time to call to order.

Article 5. Any member not satisfied with his decision on any point of order may appeal to the Association on the same day but no other time.

Article 6. Only one person shall speak at the same time who shall rise and address the Moderator when he is about to speak.

Article 7. The person thus speaking shall not be interrupted in his

speech by anyone, except the Moderator until he is done speaking.

Article 8. He shall strictly adhere to the subject, and in no wise reflect on the person who spoke before, so as to make remarks on his slips, failings, or imperfections, but shall fairly state the case and matter as nearly as he can, so as to convey his light or idea.

Article 9. No Person shall abruptly break off or absent himself from

the Association without leave obtained.

Article 10. No person shall rise and speak more than three times on one subject, without leave of the Association.

Article 11. It shall be deemd a violation of good order for any person

to laugh or whisper during public speech.

Article 12. No appellation but that of "Brother" shall be used in the Association.

Article 13. The Moderator shall not interrupt any member in or prohibit him from speaking, until he gives his light on the subject, unless he breaks the rules of this Decorum.

Art. 14. The names of the several members of this Association shall be enrolled by the Clerk, and called over as the Association begins.

Art. 15. The Moderator shall be entitled to the same privilege as any other member, provided the chair is filled, but shall have no vote unless the Association is equally divided.

Art. 16. That any member who shall willingly and knowingly break any of these laws shall be reproved as the Association shall think proper.
